



# Privacy Policy

## Irimi Company | Terms of Use, Data & Cookies

### HOW WE DO AND DON'T USE THE INFORMATION WE COLLECT

Irimi Company SAS. (“we”, “us”) is committed to safeguarding the privacy of every user who visits “www.irimi.co” (“website”). The privacy policy sets out how we collect, use, and protect the information you provide. We may change this privacy policy from time to time without notification and therefore advise you to regularly review this policy when you visit this Site.

### 1. TERMS OF USE

1.1 Ownership: All content and materials on this site, including but not limited to text, graphics, images, and logos, are owned by us or our licensors and are protected by copyright and other intellectual property laws.

1.2 Use of Site: You may use our site for lawful purposes and in accordance with these terms of use. You may not use our site in any way that violates any applicable laws or regulations, or that infringes on the rights of others.

1.3 Limitation of Liability: We are not liable for any damages arising from your use of our site, including but not limited to direct, indirect, incidental, punitive, and consequential damages. We are not responsible for any errors or omissions on our site, or for any content posted by users or third parties.

1.4 Changes to Terms of Use: We may update these terms of use at any time. By continuing to use our site after we make any changes, you are agreeing to the updated terms.

1.5 Governing Law: These terms of use are governed by and construed in accordance with French laws.

### 2. OBTAINING AND USING YOUR PERSONAL INFORMATION

2.1 We will only collect personal information from you (e.g. name, email address, the country where you live) which you provide by completing the enquiry forms or Mailing List subscription forms on the Irimi Company website (<https://www.irimi.co>).

2.2 You agree that we may obtain, hold and use the personal information you provide for the purpose of providing you with our services and ancillary services including, without limitations:-

(a) contacting you with some of our latest news, communication campaigns, and blog entries ;



(b) contacting you if we change our products, our services, our terms, or make important changes to our site if we need to give you notice of those changes;

(c) for the purpose of communicating our other products and services to you (by post, email, or other available methods) unless you indicate in writing when providing your personal information or subsequently notify us (see the contact details in the paragraph below) that you do not wish to receive such material;

2.3 You consent to transfer your personal information outside the European Economic Area in the unlikely event that processing your personal information involves such a transfer. While countries outside the EEA may not provide the same protection for your personal information as France, we will take steps to ensure that your information is used by third parties in accordance with this policy.

### **3. SHARING YOUR PERSONAL INFORMATION**

3.1 We do not share, sell or distribute personal data to or with third parties except where you have consented to this or where the transfer of your data to third parties is necessary for the purposes set out in paragraph 1.2 above.

3.2 We may transfer or assign any of the information you provide to us, including personally identifiable information, to third parties, as a result of the sale, merger, consolidation, change in control, transfer of substantial assets, reorganization, or liquidation of us or any of our group companies.

### **4. COOKIES**

4.1 In addition to asking you to submit personal information, we may collect information about you automatically when you connect to the Site. This information is not personally identifiable and includes general information about your computer settings, your connection to the internet, your browsing patterns, and your geographical location.

4.2 We may collect the above information through the use of cookies. A cookie is information that is sent to and stored on your computer when you first visit the Site and allows us to identify your computer (but not you) the next time you visit the Site. We may use the information collected in this way to adapt the Site so that it better suits you and your interest (for example, to allow us to provide features on our Associates based in your country.)

4.3 Most Internet browsers give you the option to reject all cookies, accept all cookies, erase cookies stored on your computer, or be notified before a cookie is stored on your computer. You will need to refer to your Internet browser instructions to find out more about these options and how to use them. Without cookies enabled, you may not be able to use certain features on our site.

### **5. SECURITY AND RECORDS**



5.1 Subject to paragraph 4.2 below, we strictly protect the security of your personal information and your choices regarding the use to which it is put. We use current industry standard technology to maintain the confidentiality and accuracy of the information you provided to us.

5.2 No data transmission over the Internet can be entirely secure, and while we will always use reasonable endeavors to protect your personal information, we cannot guarantee that any information you submit to us will be free from unauthorized third-party intrusion. Therefore, we cannot guarantee the security of your personal information and of your use of the Site.

5.3 We cannot guarantee that the Site is free from viruses or malicious codes. You agree that your responsibility is to satisfy yourself that your information technology is protected against such viruses and/or codes.

5.4 We may monitor and/or keep records of email communications that you send to us in the interests of our business and in accordance with this policy.

## **6. OTHER WEBSITES**
